In consideration of the public health crisis currently affecting our state, local, national, and international communities, government directives on social distancing and public health concerns associated with the spread of the COVID-19 virus and California Governor Gavin Newsom's Executive Order N-33-20 issued on March 19, 2020, the Lassen County Superior Court will be limiting access to the courthouse effective immediately. Courtrooms will practice social distancing, with any persons in the gallery instructed to sit at least two seats apart. The Court currently plans to resume regular court operations on Monday, April 13, 2020.
